

EXPOSÉ SINGING & DANCING SHOWCASE

Official Rules

MARCH 2013

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. The EXPOSÉ SINGING & DANCING SHOWCASE ("SHOWCASE") will be held on MARCH 23, 2013 at 8:00 pm, at EXPOSÉ (2142 Fountain Square, Snellville, GA 30078). The SHOWCASE is subject to all applicable federal, state and local laws.

ELIGIBILITY: You must be 16 years of age to audition. Ages 17 and under must be accompanied by a parent or legal guardian. Officers, directors, and employees of SHOWCASE, EXPOSÉ, or RICK & RUBY, LLC (as defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the SHOWCASE.

TO ENTER: You must audition to qualify for SHOWCASE. The fee for auditions is \$25.00 (USD) per person, per audition. Auditions for the competition will be held on Saturday, MARCH 16, 2013. The hours for the audition are 1:00 – 4:00 pm, and again at 5:00 – 8:00 pm EST.

PRIZE: There will be one WINNER in each category (singing and dancing). The prizes to be awarded are as follows:
(Singer) - \$100.00 & 3 hours recording studio time
(Dancer) - \$100.00 & a professional video of the dance performance

No additional prize will be awarded. SHOWCASE will furnish to the WINNERS an Internal Revenue Service 1099 form for the ARV of the prizes in the tax year in which it was awarded. If the prize is unclaimed within a reasonable time after notification, the prize award will be forfeited.

Any attempt to deliberately damage the SHOWCASE or the operation thereof is unlawful and subject to legal action by Sponsors, who may seek damages to the fullest extent permitted by law. The failure of Sponsors to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsors (excepting compliance with applicable codes and regulations), or other "force majeure" event will not be considered a breach of these Official Rules. RELEASED PARTIES assume no responsibility for any injury or damage to entrants' or to any other person's computer relating to or resulting from entering or downloading materials or software in connection with the SHOWCASE. RELEASED PARTIES are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. Sponsors reserve the right to cancel, modify, or suspend the SHOWCASE or any element thereof (including, without limitation, these Official Rules) without notice in any manner and for any reason (including, without limitation, in the event of any unanticipated occurrence that is not fully addressed in these Official Rules). In the event of cancellation, modification, or suspension, Sponsors reserve the right to select WINNER in a random drawing from among all eligible, non-suspect Entries received prior to the time of the event warranting such cancellation, modification, or suspension. Notice of such cancellation, modification, or suspension will be posted at www.rickandruby.com. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
